




One of the most striking scenes at the Last Supper happens when Jesus pulls off his tunic; has the disciples remove their sandals, and begins a



most famous line from the Last Supper. "This is my body. This is my blood." Instead of pointing at the bread and wine, he gives an example of service. We begin to see that Eucharist involves more than food

and drink --- it involves commitment, community, faith and selflessness. We as Knights of Columbus exemplify this through our commitment to community, our faith and works for others as selflessness. Jesus says in this Gospel of John, that the washing of feet is an outward sign of service to others, the selfless service of Christ is an example of faith in action. If we are believers, if we share in the bread and the cup, then we also share in service.

We often hear the complaint that the washing of feet is too old-fashioned, and doesn't fit the modern culture. Sometimes we search for a more meaningful adaptation like the washing of hands. But it is hard to beat the shocking humility of the original gesture. It didn't fit Jesus' culture very well either. Peter objected to the whole idea. The service to which Jesus calls us, Brother Knights, also doesn't fit the culture of this present day. But we know that the service of the Gospel is freely given. Holy Thursday invites us to the table not as guests who dine and run, but as hosts who eat and SERVE. The meal isn't over till the cleanup.

In SERVICE we share this wonderful Holy Week, this Easter season and I am most Blessed to serve you my Brother Knights.
