

**The Need for Lent**  
Again we come to the beginning of Lent for this coming year. The message is always the same: we must repent. this disordered condition as healthy or natural. We have been lulled into complacency of a drug which is sin. We need restoration, we need health, we need wholeness again. The prophets insist on it and Jesus steadfastly confirms the need for repentance. Repent, the kingdom of God is at hand. The season of Lent and also of Advent are two special seasons which reflect the need of change, conversion, redirection and a rethinking of our basic attitudes and assumptions.

The road to health and peace is through Lent and the change of course. We must examine again and again our priorities and the foundations of our lives. God must be put first. He must be ahead of all persons and things. He must live in my being, in my thoughts, in all emotions and my soul. It is only when Christ is restored in me and everything, that a healthy wholeness can be actualized in me, in others, and in the whole of creation. We are at the vanguard. We destroyed the peace and we are the ones who can, with God's grace, restore it. Let us repent and let us begin the process of restoration. We change and the world changes. We are fragmented and the world remains fragmented. Let us move back to Christ. This is the spirit of Lent and all Lents. Let us begin now.


We were very happy to have some families from the Jesus Mary and Joseph Home in attendance which added to the family atmosphere.

## Haiti News

Knights of Columbus donations from state and local councils and from individual members for Haiti earthquake relief exceeded \$144,000 twelve days after the January 12 disaster. \$135,000 of the total came from the US, and \$9,000 came from Canada. The donations are in addition to the \$50,000 contribution made by the Supreme Council to Catholic Relief Services immediately following the earthquake.
